- B. Red Flags Levels The pole by Mark Caples's house broke. It needs to be fixed. Scott Chisholm has not heard anything from the drain commission.
- C. Shady Beach tree in roadway 5 trees are scheduled to come down. DTE is being asked to remove the trees, if they do then the money will be used to remove other trees.
- D. Potential Township Keyholing Ordinance –Scott Chisholm is waiting for a response from the township in regard to the ordinance he submitted to the township for approval.
- E. Lakeshore Dr gravel Mark Caples motioned spend up to \$750 to start building up the road. Seconded by Brian Trim. Bruce LaRue suggests that Lakeshore Dr be handled the same was as the Schrum bridge. Ken Johnson suggests that the road be added to by crushed concrete instead of gravel. Motion is amended to uses crushed concrete to raise the road. Motion carried.

- b. Reduction of Board Meetings Scott Chisholm suggests that the number of board meetings be reduced to 1 meeting every two months. Mark Caples motioned to reduce the meetings down to 6 annually, 1 every two months. Ken Johnson seconded. By-Laws state that the board must meeting April, July, August and October. The annual membership meeting must be in June, July or August. Mark Caples motion is amended to specify July meeting will be the 28th, August will be the 18th and the membership meeting is August 23rd. Seconded by Bruce LaRue. Motion carried.

- d. Lake Weed dues Back lot weed dues for 2020 is \$14, Lake Front is \$25. \$12,000 remains in the weed account. Brian Trim motioned to accept the weed dues as presented. Seconded by Mark Caples seconded. Motion carried.
- e. Change to Public forum rules Mark Caples suggests reducing the public forum time limit to 3 minutes like other public forums. Also eliminate the back and forth between the public and the board. Ken Johnson seconded. Members can contact their trustee to communicate any issues. Mark Caples amended the motion state the board will remain silent until the end of the public forum and he removed the 3-minute limit from the motion. Seconded by Brian Trim. Motion carried. Brian Trim motioned to limit the public forum to 3 minutes. Seconded by Bruce LaRue. Motion carried.
- f. **Holiday Light Contest** Sandi Bodi announced the winners of second place went to a renter. There was some controversy over that fact. If the owner is not current on their due's property should not be included in the contest. And the previous years winner should be ineligible for a prize. George Brown suggests that the committee document the procedure.
