Public Forum - Marty Blank spoke. He wanted to bring to the attention of the board that the accounting in November Treasurer's report showed the roads as a passthrough. Response from the board; issue getting the road captains together to implement the changes to the road accounting.

New Business

- (a) Weed Assessment 2019 Calculation George Brown has calculated the weed assessment per the by-laws. Delinquency rate increased from 16% in 2018 to 18% 2019. Calculated back lot assessment for 2019 is \$11, a decrease of \$3 from last year, Lake front is \$25 decreased by \$7. Ken Johnson motioned to accept the 2019 weed assessment calculation. Brian Trim seconded. 8 ayes 1 abstain. Motioned carried.
- (b) Foreclosures- We have a blanket lien. Title companies must contact HOA when a property is to be sold. To clear the lien, seller must pay delinquent dues before title can be released. Can we put a something on their credit report? Foreclosure by advertising needs to be discussed with our lawyer. Recommend next step is to update the by-laws to include the ability to foreclose by advertising. Contact credit agencies to investigate adding lines to credit reports. Can the township add our dues and road dues to the tax assessment?
