(a) Buoys at Shady Beach – Need a conservation officer to approve the sketch, which includes the buoy placement. Distance off shore is from the conservation officer too. Suggestion to use the existing beach at Schrum as a template to sketch the buoys for Shady Beach. The floating dock at Shady Beach is drifting needs to be anchored. Discussion on whether the raft needs to be included in the sketch of the swim area.

Lake Committee – We have already paid \$1050 for testing on 3 sites, twice this year. We could cancel for a refund. Spring quality of the lake was excellent. Fall testing still has to be completed. It would provide a comparison. For our information: Duck Lake has incorporated aeration into a pump house. Their lake has gotten deeper, because the muck level has dropped at least 1 foot. We had a cursory look in a prior year and the estimate was \$25,000 per year. Bruce LaRue will investigate further.
