Friendly reminder:

Blight is one of the most common issues of complaint in our neighborhood. The term "blight" refers to several aspects, such as unregistered/unusable vehicles, long-term outdoor storage of equipment/junk/garbage or other unsightly material visible to neighbors or the road, or even the unruly overgrowth of foliage, grass, or weeds. Per Article IV, Section I of the Bylaws (as well as local ordinance), please be advised that all vehicles visible to the road must be registered. All long-term outdoor storage of equipment, junk or other materials must be covered by a 6-foot panel or fence. Please tend to foliage on your property to help maintain a safe, healthy, and pleasant environment. In addition, it is important to maintain the structural integrity of our properties. Homes left in disrepair contribute to the issue of blight in our neighborhood. Please feel free to contact the HLC Board if you have questions about what constitutes blight. We thank everyone for their attention to this matter, and we thank those residents who are already keeping their properties maintained.
